

Remington Promotion Terms & Conditions (NZ) iChoose Visa Prepaid Card

1. Information on how to participate in this REMINGTON promotion forms part of these Terms and Conditions. Claims that do not comply with these Conditions of Entry are ineligible. **Internet access and a valid email account are required to claim a reward. Claim forms sent via Post, facsimile or any other method will not be accepted.** By claiming a reward, Participants agree to be bound by these Terms and Conditions.
2. Employees of the Promoter, REMINGTON Dealers/stockists and the affiliated companies and agencies of the Promoter and REMINGTON Dealers/stockists are ineligible to claim a reward. Government Departments, Hire Companies and Direct Commercial Accounts (Key Account Holders) are eligible to claim. The promotion is only open to Participants. "Participants" means residents of New Zealand (other than the excluded persons set out in this clause 2), who purchase a qualifying Product from an authorised REMINGTON Dealer/stockist during the promotional period for personal use. "Personal use" excludes purchases for the purpose of resale. Participants under 18 years old must have parental/guardian approval to claim and further, the parent/guardian of the Participant must read and consent to these Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor submitting a claim in this promotion. "Product" refers to the REMINGTON Product model mentioned within clause 4. The iChoose Visa Prepaid Card's value is for the sole and exclusive claim in respect of a purchase of a Product. The Promoter reserves the right to request the details of individual redemptions and proof of sale. By participating in this promotion, authorised REMINGTON Dealer/stockist accepts the full Terms and Conditions, and agree to provide the Promoter, upon request, details of any transaction to validate that the Products were not sold. It is the individual REMINGTON Dealer/stockist's responsibility to ensure all their staff are fully aware and abide by these conditions.

6. Final claims must be lodged by 11:59pm NZDT on **31 May 2019** in accordance with clause 7. Participant(s) will forfeit claims not made by this date.
7. To lodge a claim, the Participant must visit www.remingtonproducts.co.nz/iplvisait and complete the official on-line claim form by entering their details, answering the associated questions, uploading proof of purchase and entering the unique serial number from their purchased Product. Claims must be lodged via the REMINGTON internet site only by the date specified in clause 6. Claim forms sent via Post, facsimile or any other method will not be accepted.
8. Multiple claims per person are accepted. Each claim must include proof of purchase and a unique serial number. Each Product purchased can only be used once for redeeming one reward. Claims will be deemed invalid if the same serial number is used on more than one claim. The Promoter reserves the right to request that claimants present proof of purchase in the form of a purchase receipt (clearly showing that a Product was purchased, store of purchase and purchase date) for all claims for reward claim validation. Failure to provide proof of purchase for all claims submitted may result in invalidation of all claims at the Promoter's discretion.

10. Please allow for up to 60 days from the date that the claim is validated for processing. Claimants will be notified that their claim has been submitted by email and will also be notified via email if any issues arise with their claim. iChoose Visa Prepaid Card will be delivered to the Participant's nominated New Zealand address (as specified on the claim form).
11. The iChoose Visa Prepaid Card is subject to the iChoose Visa Prepaid Card Terms and Conditions and the User Guide that is delivered to the Participant. Participants must read accept the iChoose Visa Prepaid Terms and Conditions and follow the instructions on the User Guide to activate their iChoose Visa Prepaid Card prior to using it in store.
12. **If a Participant claims the reward and later returns or exchanges the Product, due to a defect in the Product, in accordance with and subject to law and the relevant REMINGTON Dealer's/stockist's Terms and Conditions of sale, then the amount refunded or credited to the Participant will be the amount paid for the Product, less the reward amount of \$100.**
13. The Promoter reserves the right to extend the closing date of the promotion at its discretion.
14. With the exception of ordinary Product discounts, in the form of in-store sales offered by REMINGTON Dealer's/stockist's the promotion is not valid in conjunction with any other promotional offer.
15. The Promoter's decision on all matters pertaining to this Promotion is final and binding and no correspondence will be entered into.
16. Claims and rewards are not transferable, exchangeable, redeemable for cash or assignable, unless otherwise specified by the Promoter.

18. If the iChoose Visa Prepaid Card is unavailable, the Promoter, in its discretion, reserves the right to substitute the iChoose Visa Prepaid Card with a reward to the equal value and/or specification.

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify any statutory consumer guarantees as provided under consumer protection laws in New Zealand ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
20. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any theft, unauthorised access or third party interference; (b) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (c) any tax liability incurred by a Participant; or (d) taking/redemption of a reward.
21. The Promoter will use the information contained in the claim form to contact Participants if it has any queries regarding claims.
22. The Promoter reserves the right to verify all entries. Entries are void if illegible, forged, incomplete, indecipherable or tampered with in any way. No responsibility is accepted for late, lost or misdirected claims via the Internet. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant. Any cost associated with accessing the promotional website is the Participant's responsibility and is dependent on the Internet service provider used.

The Promoter reserves the right, at its sole discretion to disqualify any claimant who the Promoter has reason to believe has breached any of these Terms and Conditions, has not purchased for personal use (in the sole opinion of the Promoter), or engaged in any unlawful or other improper misconduct calculated to jeopardize the fair and proper conduct of the promotion. The Promoter reserves its rights to recover damages or other compensation from such an offender. Errors and omissions may be accepted at the Promoter's discretion. To the extent permitted by law, the Promoter and its agents exclude liability for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, or providers, computer equipment, software, technical problems or traffic congestion on the Internet or any web site, or any unauthorised intervention, incorrect or insufficient supplied merchant identification parameters, or any combination thereof, which cause injury or damage to the Participant's or any other person's computer related to, or resulting from, participation or attempted participation in this promotion.

If for any reason this promotion is not capable of running as planned including: infection by computer virus, bugs, tampering, requirement of a regulatory body, unauthorised intervention, fraud, technical failures, incorrect or insufficient supplied merchant identification parameters, or any other causes beyond the reasonable control of the Promoter, which corrupt or affect the administration security, fairness integrity or proper conduct of this redemption, the Promoter reserves the right in its sole discretion to the extent permitted by law, to cancel, terminate, modify or suspend this promotion and/or to disqualify a Participant.
26. The Promoter collects personal information about Participants for the purpose of including Participants in the promotion. Unless otherwise notified by the Participant to the Promoter in writing, in providing their personal details, each Participant agrees to the Promoter using their details for future marketing and publicity purposes, to the extent permitted by the law, and to the Promoter disclosing such information to third parties, such as agents, contractors and service providers, for this purpose. If any information requested is not provided, the purchaser may not participate in this promotion. All personal details of Participants will be stored in a database at the office of the Promoter or its agencies. The Promoter is committed to the protection of personal information.
